


WHAT DOES SHARE HOMES PROVIDE FOR FOSTER PARENTS:

## OUR MISSION

## WHO WE ARE

Share Homes, Inc. is a non-profit (Tax I.D. #94-3042623) public benefit corporation incorporated and licensed as a foster care agency in Lodi, California in 1987 (#390310451). The Elk Grove office was licensed in 1999 (#347001320). The adoption license was received in 2002 (#397001963).

## WHAT WE DO

Share Homes provides foster homes to children between the ages of birth to 18 years. We are committed to providing a safe, nurturing environment through our network of caring foster parents. Our goal for the foster children is to become responsible adults and positive role models.

## BACKGROUNDS OF CHILDREN WE SERVE

- Physically abused
- Sexually abused
- Emotionally abused
- Neglected

## WHO CAN FOSTER:

- Married or single individuals
- At least 18 years old
- Rent or own your home
- Have sufficient income to support yourself
- Be in good health, physically and mentally
- Working or stay at home parents
- Parents with or without specific religious beliefs

## FOSTER CARE APPLICANTS MUST:

- Be fingerprint and child abuse cleared for foster care, as well as, other adults living in the home
- Pass licensing and agency regulations
- Have a valid CDL, clean driving record, and an insured, safe, operating vehicle
- Complete the entire process, which includes: orientation, pre-certification training, paperwork, and a home study
- Live within two hours of our office



## 6 TYPES OF PLACEMENTS:

- **Respite**-up to 30 days, short-term care, like babysitting
- **Emergency Placement**-placements that need homes immediately may be short-term and may know only limited information on the children.
- **Reunification**-placements for a period of 6 months to two years with weekly visits. Goal is to reunify the children with their parents.
- **Long-Term**-children usually 6 and older who will stay in foster care until emancipation.
- **Concurrent Planning**-Children with two plans:
  - 1) Child evaluated for adoption if birth parents do not comply with court order.
  - 2) Child reunified with parents who do comply with the court order.
- **Fost/Adopt**-foster children placements that lead to adoption.

## **The foster care certification process includes:**

- A two hour orientation
- An eight hour pre-certification training
- CPR and First Aid training
- Fingerprint and background check
- Three home visits to complete a screening interview, a home safety inspection, and a home study.
