## FEES INVOLVED WITH ADOPTION

It is Share Homes policy not to charge fees for adoption. However, there are fees for the following requirements:

- Fingerprint clearance
- CPR/First Aid certification
- Health screening
- Other miscellaneous expenses

After the finalization of your adoption, you may be reimbursed up to \$400.00 for non-recurring adoption expenses through the County - so keep receipts after the adoption is finalized. There is also a \$10,000 tax credit per child available once the adoption has been completed. Please check with your tax advisor as to current laws.

#### ADOPTION APPLICANTS MUST:

- Be fingerprint and child abuse cleared for adoptions, as well as, other adults living in the home
- Pass licensing and agency regulations
- Have a valid CDL, clean driving record, and an insured, safe, operating vehicle
- Complete the entire process, which includes: orientation, precertification training, adoption training, paperwork, and an indepth home study
- Live within two hours of our office
- Be certified as a foster parent as well



REQUIREMENTS

Persons wishing to adopt are required to go through our foster care licensing process prior to being approved as an adoptive home. (This does not mean that prospective adoptive parents must provide foster care).

Children being considered for adoption must reside in the prospective adoptive parent's home for at least six months as a foster child prior to adoption. Therefore, your home will be certified as both a foster and adoptive home.

# The foster care licensing process includes:

- A two hour orientation
- An eight hour pre-certification training
- CPR and First Aid training
- Fingerprint and background check
- Three home visits to complete a screening interview, a home safety inspection, and a home study.
