## OUR MISSION

It is the mission of Share Homes that all children utilizing the services will be provided with a safe environment to visit with their parents and that exchange services will transition smoothly, without reason for conflict. It is also the mission of Share Homes to connect the family law community to education and support for children to have conflict-free access to both parents through a continuum of services.

## WHO WE ARE

Share Homes, Inc. is a non-profit (Federal Tax I.D. #94-3042623) public benefit corporation founded in Lodi, California in 1987. In 1999 an additional office was established in Elk Grove. Share Homes has been supervising visits for the Human Services Agencies throughout Northern California for over 23 years. Share Homes also provides therapeutic/counseling services and co-parenting classes.

## ROLE OF PROVIDER IS TO:

- Uphold the legal process of conducting the court supervised visitation between the custodial/non-custodial parents
- Schedule appointments for visitation
- Assure visits are safe and free of unnecessary stress
- Assure the child will never be left alone during visitation
- Actively monitor the conversation during the visitation
- Cancel the visit if the visit is not in the best interest of the child

- Document precisely what is being observed and what is being said during the visit
- Meet the qualifications outlined in the rules of the court
- Be responsible for monitoring and recording visitation exchanges, mediation, interviews and other related services through the supervision program



## SUPERVISED VISITATION

Share Homes provides supervised visitation to families involved with the family court system. Supervised visitation can be court ordered for many reasons. The goal of Share Homes is to provide qualified staff to supervise visits in order to achieve the safest, most productive environment that is conducive to building or maintaining relationships. Share Homes facility has the space to accommodate both indoor and outdoor activities as well as coordinating offsite visits.

## INFORMATION NEEDED FOR INTAKE

- Referral documents/court orders
- Criminal records/order of protection
- Bail or probation conditions
- Assessment reports
- Child health conditions

## The supervised visitation intake process includes:

- The non custodial parent calling 1-888-99 SHARE for an intake appointment
- Rules of visitations as outlined for both the custodial/non-custodial parent
- Visitation scheduling for on-going visits
